WAIVER AND RELEASE OF ALL CLAIMS**

IN CONSIDERATION OF MY PARTICIPATION IN THE CASTRO VALLEY SPORTS FOUNDATION LAKE CHABOT TRAIL CHALLENGE 5K AND HALF MARATHON HELD ON JUNE 7, 2020 [hereinafter referred to as the “Event”], I HEREBY WAIVE, RELEASE, COVENANT NOT TO SUE, AND FOREEVER DISCHARGE CASTRO VALLEY SPORTS FOUNDATION, its officers, directors, race directors, coaches, volunteers, agents, East Bay Regional Park District and all other person(s) associated with the Event from any and all liabilities, actions, claims for damages against any of the aforementioned individuals or entities arising out of or in any connected with the Event, including without limitation any discomfort, illness, injury or accident which may occur while traveling to and from the Event, participating in the Event or while on the premises of the Event.

I ASSUME FULL AND COMPLETE RISK AND RESPONSIBILITY FOR ANY DISCOMFORT, ILLNESS, INJURY, DAMAGES OR ACCIDENT which may occur while I am preparing for the Event, during the Event, while I am on the premises of the Event, or while I am traveling to and from the Event. I understand that participating in the Event may be hazardous and that I should not enter or participate unless I am medically able, physically able and properly trained. I understand and acknowledge that it is my responsibility to consult with my doctor before participating in the Event. I understand and acknowledge that it is my responsibility to ensure that at all times I am medically and physically fit to participate in the Event.
